

ALBERTA ENERGY REGULATOR

The Alberta Energy Regulator (AER) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

1) The following table shows

- the specified pools and wells in the **FERRYBANK Field** wherein production may be commingled in the wellbore, and
- the allocation factors to prorate the commingled production to the specified pools:

2) Coalbed methane and non associated gas production from the EDMONTON GRP, HORSESHOE CANYON FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 44, RANGE 26, WEST OF THE 4th MERIDIAN:
Section 30

IN TOWNSHIP 44, RANGE 27, WEST OF THE 4th MERIDIAN:
Section 36

IN TOWNSHIP 45, RANGE 26, WEST OF THE 4th MERIDIAN:
Sections 4, 6, 16, 22, 28

IN TOWNSHIP 45, RANGE 27, WEST OF THE 4th MERIDIAN:
Section 12

- 3) Coalbed methane and non associated gas production from the EDMONTON GRP, HORSESHOE CANYON FM, LETHBRIDGE, RIBSTONE CREEK MBR, VICTORIA MBR, and BROSSEAU MBR may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 45, RANGE 26, WEST OF THE 4th MERIDIAN:
Sections 18, 29, 32

IN TOWNSHIP 45, RANGE 27, WEST OF THE 4th MERIDIAN:
Section 2

- 4) Coalbed methane production from the HORSESHOE CANYON FM may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 43, RANGE 28, WEST OF THE 4th MERIDIAN:
Sections 13-15, 22-27, 34-36

IN TOWNSHIP 44, RANGE 28, WEST OF THE 4th MERIDIAN:
Section 3

- 5) Coalbed methane production from the HORSESHOE CANYON FM and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 45, RANGE 27, WEST OF THE 4th MERIDIAN:
Section 30

- 6) Board Order No. MISC 2006-47 is rescinded.

- 7) Allocated production applies to production of gas only. All oil production is to be reported to the Ferrybank Lower Mannville EE Pool.

- 8) AER Order No. MU8137 is rescinded.
