- 2) Gas production from pools in the Clearwater Formation may be taken without segregation in the wellbore from wells located in the following areas:

IN TOWNSHIP 81, RANGE 5, WEST OF THE 4TH MERIDIAN:

Sections 4 to 9 inclusive, and Sections 16, 17, 18, and 31

IN TOWNSHIP 81, RANGE 6, WEST OF THE 4TH MERIDIAN:

Sections 11 and 12

IN TOWNSHIP 82, RANGE 5, WEST OF THE 4TH MERIDIAN:

Sections 29 to 33 inclusive

IN TOWNSHIP 82, RANGE 6, WEST OF THE 4TH MERIDIAN:

Sections 14, 15, 16, 21, 22, 23, Sections 25 to 28 inclusive and Section 36

IN TOWNSHIP 83, RANGE 5, WEST OF THE 4TH MERIDIAN:

Sections 4 to 9 inclusive, Sections 18, 19, and 30

IN TOWNSHIP 83, RANGE 6, WEST OF THE 4TH MERIDIAN:

Sections 1, 2, Sections 11 to 14 inclusive, and Sections 23 to 26 inclusive
